Sunrise Beach Voters to Decide April Ballot Issue

Village of Sunrise Beach voters will be asked to approve additional bonding capacity for the Water and Sewer system at the April 8 municipal election. The ballot question is as follows:

Shall the Village of Sunrise Beach, Missouri, issue its Combined Waterworks and Sewerage System Revenue Bonds in the amount of \$15,000,000 for the purpose of acquiring, constructing, furnishing, equipping, extending and improving the Village's combined waterworks and sewerage system, including the acquisition of real estate and easements related thereto, the cost of operation and maintenance of said system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the Village from the operation of its combined waterworks and sewerage system, including all future extensions and improvements thereto?

The ballot initiative represents a continuation of the program that was first approved by voters in 2009, when \$8 million in bond issues were authorized to finance the Village's new water and sanitary sewer system. The Village has since constructed its system to many parts of Sunrise Beach, though future phases remain in the works. The Village has used \$6.8 million of the original \$8 million bond capacity to date, and is requesting an additional \$15 million in bond capacity with the new ballot question. If approved, the Village anticipates using the Missouri State Revolving Fund (SRF) program for future phases, similar to how the past phases were constructed. Village Monitoring SEMA Floodplain Mapping Project

The Village is keeping a close eye on a floodplain mapping project currently underway in the Lake region. The Missouri State Emergency Management Agency (SEMA) has been working on a remapping project for several years, which recently has come under scrutiny from local elected officials, realtors and others. The Village has not taken an official position on the issue, but in general we are wary of any increase in the floodplain in the Lake area, and we would join Rep. Jeff Vernetti in his recent calls for the project to be put on hold, or scrapped altogether. If the mapping project does proceed, the Village will receive official notifications from SEMA, which will be passed along to affected property owners and the general public.

Sunrise Beach in the Community

Village officials and staff are making an effort to be more visible in the community, participating in a number of community events recently. We had an entry this year in the St. Patrick's Day Parade on the Bagnell Dam Strip and also was in the Laurie Fair parade last fall. We will be at the Lake West Business Expo on March 29, and will be the host sponsor of Coffee with the Chamber May 1 at Lake West Chamber. We also plan to participate in career days this spring at Camdenton High School and School of the Osage in April. The Police Department also participates in various community initiatives, including the Holiday Shop with a Hero. We have a very giving community; it's our honor to give back!

Project to Codify Village Ordinances is Nearly Complete

The Village is nearing completion of a major project to codify its ordinances and make them readily available to the public. The Board of Trustees is scheduled to take final action on the project at its April 14 meeting. The project has been several months in the making and has been a partnership with General Code, which handles codification projects throughout the country. The project essentially codifies the Village's existing ordinances, some of which date back to its original incorporation in 1954, and combines them with provisions of Missouri statute and certain model ordinances pertaining to municipal government. The Village has also updated certain ordinances which were out of date or no longer compliant with provisions of Missouri law. Prior to the codification project, the Village ordinances were kept in paper binders at City Hall and were only available upon request. Codification will make the ordinances readily available to staff, including police officers in the field, as well as the general public. MoDOT Projects Affecting the Lake

The Village stays in regular contact with the Missouri Department of Transportation, and in particular with Danny Roeger, MoDOT area engineer for Camden County. The following is a brief summary of MoDOT projects, based on recent discussions with Mr. Roeger.

When will the toll bridge plaza work be finished?

The temporary signals and lane changes should be done by the end of March. The total project completion is currently scheduled for May 1.

How much has traffic increased on Route MM since the toll bridge "opened" (ie no more tolls)?

Traffic counts in general are up about 40 percent in the past year. We are also seeing an increase in commercial truck traffic. The peak traffic day is ... (probably not a surprise) Friday.

What is in the plans for the Route MM-TT-F corridor into Sunrise Beach?

No major construction is in the current MoDOT plan. However the project is on the "Unfunded Needs List" for Camden County (as determined by Lake Ozark Council of Local Governments), which could potentially lead to some improvements over the next few years.

What about Highway 5 through Sunrise Beach (and beyond)?

Unfortunately there are no widening or third-lane improvements scheduled for Sunrise Beach in the near future. However this corridor also could potentially move up the list in future years, depending on traffic counts and other factors.

No CDBG Grants This Year

The Village recently learned that it was not selected for two state grants it had applied for, requesting assistance for the paving of Beachwood Drive, American Legion Road and Eddie Avenue. The news came as a surprise to the Village, which felt it had a strong change to receive at least one of the two grants (Community Development Block Grants, available through Missouri Department of Economic Development). Upon review with state officials, the Village was told that 80 grants were received and 37 were awarded, with five communities actually receiving multiple awards. No city in the Lake region was selected for funding, and the nearest awardee was Russellville, south of Jefferson City. Of the 37 awards, 21 were in the southeast part of the state. On the plus side, it does appear that the Village remains a good fit for the program, and has tentative plans to apply for the next round later this year.



Did you know?

The Hurricane Deck bridge was originally constructed in 1934, shortly after Bagnell Dam was completed. Prior to the bridge construction, vehicles crossed the Osage River by ferry. The Hurricane Deck bridge was originally a toll bridge, with the cost reportedly at 40 cents per each car and driver, plus five cents per each passenger. The bridge was one of only three of its type built in Missouri, with the other two also being built over the Lake of the Ozarks (the Grand Glaize bridge and Niangua Arm bridge). The Hurricane Deck bridge was noted for its beautiful construction and quickly became one of the Lake area's most iconic features. It was replaced by a new bridge in 2013.
